

WORKERS' COMPENSATION AND REHABILITATION ACT 1981

VARIATIONS IN PRESCRIBED AMOUNT AND OTHER WORKERS' COMPENSATION PAYMENTS

EFFECTIVE 1 JULY 1995

In March 1995, the index of weighted average minimum weekly award rates for adult males in Western Australia was 140.0 compared with 138.2 in March 1994, an increase of 1.8 index points, or 1.30246 percent.

In accordance with Part 1, section 5 of the Act, that percentage was calculated and added to the existing Prescribed Amount of \$100,729 to give a new Prescribed Amount of **\$102,041.00** effective from 1 July 1995.

The consequential adjustments to other payments, also effective from 1 July 1995 unless otherwise stated are as follows:

- (b) in relation to a worker without a dependent spouse, to the sum of **\$45.00** with effect from 23 August 1994.
