

WORKERS' COMPENSATION AND REHABILITATION ACT 1981

VARIATIONS IN PRESCRIBED AMOUNT AND OTHER WORKERS' COMPENSATION PAYMENTS

EFFECTIVE 1 JULY 1998

The indexation of the Prescribed Amount for 1 July 1998 is based on a forecasted increase in the Australian Bureau of Statistics' Award Rates of Pay Indexes of 1.5%.

In accordance with Part I, section 5 of the Act, this percentage was calculated in accordance with the regulations and added to the existing Prescribed Amount of \$104,810.00 to give a new Prescribed Amount of \$106,382 effective from 1 July 1998.

The consequential adjustments to other payments, also effective from 1 July 1998 unless otherwise stated, are as follows:

In accordance with clause 1 of the Schedule, the existing Redemption Amount of \$34,914.00 was increased by 1.5% to **\$35,438** with effect from 1 July 1998.

In accordance with Regulation 17A of the Workers' Compensation and Rehabilitation Regulations 1982 - 94 , amended 8 August 1997, the Supplementary Amount referred to in clause 1 of the Schedule is increased as follows:

- (a) in relation to a worker with a dependent spouse,
from the sum of **\$86.00** to **\$88.00**;
- (b) in relation to a worker without a dependent spouse,
from the sum of **\$49.00** to **\$50.00**;

"Amount B" means, for the financial year ending on 30 June 1999, the amount of **\$5,000.00**.
