AMS03	Examination and provision of report and certificate — complex assessment (eg. multiple injuries; severe impairment such as spinal cord injury or head injury) — other than a service mentioned in item 4, 5, 6 or 8.	\$2,063.40 (or, if an interpreter is present at the examination, \$2,407.20 excluding any fee payable to the interpreter)
