EPE05	<p>Gym membership/Entry fees</p> <p>Includes direct cost of membership (pool or gym).</p> <p>Prior approval from insurer required.</p>	Market rates

EPE08	<p>Communication</p> <p>Any requested or required oral communication with relevant parties (treating medical practitioners, employers and insurers) relating to the treatment of a specific worker.</p> <p>Excludes courtesy communication such as acknowledgement of referral and brief updates to the medical practitioner.</p> <p>Maximum time allowable per communication of 30 minutes.</p>	\$20.45 per 6 minute block
