



Workers' Compensation and Injury Management Act 1981

Indexation of Workers' Compensation Payments 2021/22

Effective 1 July 2021

For the financial year beginning 1 July 2021, the Prescribed Amount has been indexed by varying the amount for the previous financial year by the percentage yearly variation in the Wage Price Index ordinary time hourly rates of pay (excluding bonuses) for Western Australia, varied between the second last December quarter before the financial year commenced, and the last December quarter before the financial year commenced, as published by the Australian Bureau of Statistics (ABS).

The consequential adjustments to other payments, also effective from 1 July 2021, unless otherwise stated, are as follows:

¹ An additional amount of up to 75% of the Prescribed Amount may be ordered where a worker suffers permanent total incapacity and his/her social and financial circumstances justify it.

² An additional amount of up to \$50,000 may be ordered by an arbitrator where a worker's social and financial circumstances justify it. An additional amount of up to \$250,000, beyond the \$50,000, may be ordered by an arbitrator in the circumstances described in Schedule 1, sub-clause 18A(2aa) of the *Workers' Compensation and Injury Management Act 1981 (the Act)*.

Weekly payments

For the purposes of paragraph (c) of the definition of "Amount C" in section 5A(1A) of the Act, the amount for a financial year is worked out by multiplying by 2 the average of the amounts that the Australian Bureau of Statistics (ABS) published as the all employees average weekly total earnings in Western Australia for pay periods ending in the months of May and November preceding the financial year.

"Amount C" for the period 1 July 2021 to 30 June 2022 is: \$2,772.00
