



Workers' Compensation in WA

WorkCover WA is the government agency responsible for overseeing the workers' compensation and injury management scheme in Western Australia (WA). WA operates a privately underwritten workers' compensation scheme. This means that private insurance agencies are approved by WorkCover WA to provide workers' compensation insurance to WA employers.

Additionally, WorkCover WA also exempts employers who have the material and financial resources to cover their own liabilities from any workplace injuries that may occur, from having to obtain workers' compensation insurance from an approved insurer. Exempt employers are commonly referred to as self-insurers.

Currently, there are eight approved insurers and 24 self-insurers who manage claims within the WA workers' compensation scheme.

The WA workers' compensation scheme is a defined benefits scheme. Injured workers are able to access entitlements to assist with covering expenses for a work-related injury or disease. This includes medical, allied health, external workplace rehabilitation and other health care services as part of injury management and return to work processes.

Purpose of report

This annual report details activities associated with treatment services provided within the WA workers' compensation scheme. Hospital charges and legal expenses are not considered to be treatment services, and therefore excluded. In this report, treatment services are broadly grouped under:











During 2019/20, over a million services were provided, which included allied health, medical, workplace rehabilitation, and other treatment services. While the number of claims decreased by 12% over the last four years, the number of services provided slightly decreased by 3%.

In 2019/20, \$961 million was paid out in the WA workers' compensation scheme, of which \$171 million was associated with treatment services. Between 2016/17 and 2019/20, both the total claim payments and service payments decreased (3% and 4% respectively).

Proportion of claims with treatment services by occurrence year


This graph shows the proportion of claims which received treatment services since the occurrence of the work-related injury or illness.

Around 91% of claims received treatment services in the same year as the injury/disease occurred.

For the subsequent year, only 32% to 37% of claims continued to have treatment services, and decreased to around 3% by the third year post-injury or illness.



Total claim payments



In 2019/20, around two-thirds of total claim payments were made directly to the worker (either by income replacement or lump sum). Payments for treatment services, such as medical, allied health, workplace rehabilitation, and other treatment services, accounted for 18%.

Hospital charges and legal expenses are not considered to be treatment services, and are categorised with 'other payments'.



Total treatment service payments by service type (\$million)














Total treatment service payments proportions by service type























Average treatment service payments



Average treatment service payment by service type












Over a four-year period, the average medical service payment was 1.6 times higher than the overall average treatment service payment.

Allied health services




In 2019/20, \$40.7 million was paid for allied health services, accounting for 24% of all treatment service payments.
The total service payments for allied health increased (1.6%) from 2016/17 to 2019/20.

Allied health treatment includes services such as ambulance services, dentistry, exercise based program, occupational therapy, and physiotherapy. Ambulance service payments had the largest increase (15.3%) from 2016/17 to 2019/20, but accounted for a small proportion (5.5%) of allied health service payments.

Proportion of allied health service payment types

In 2019/20, physiotherapy accounted for 34.4% of the total allied health payments, followed by exercise based program (31.8%), and occupational therapy (14.7%).



Profile of medical services



Medical services




In 2019/20, \$86.0 million was paid for medical services, accounting for 50% of all treatment service payments. The total payments for medical services decreased (9.3%) from 2016/17 to 2019/20.

Medical services include services for medical nonscheduled items, general practitioners, diagnostic imaging, anaesthetists and specialists. Medical nonscheduled items accounted for the largest proportion of medical service payments, but decreased (15%) from 2016/17 to 2019/20.

Proportion of medical service payment types

In 2019/20, medical non-scheduled items accounted for 27.8% of the total medical service payments, followed by general practitioners (21.2%), and diagnostic imaging (17.4%).



Workplace rehabilitation services




In 2019/20, \$37.1 million was paid for workplace rehabilitation services, accounting for 22% of all treatment service payments.

The total payments for workplace rehabilitation services increased (1.9%) from 2016/17 to 2019/20.

Workplace rehabilitation includes services for case management, workplace activities, travel, placement activities and reports (general). Workplace activities had the highest increase in service payments (38.4%) from 2016/17 to 2019/20, whereas payments for placement activities had the largest decrease (31.1%) over the same period.

Proportion of workplace rehabilitation payment types

In 2019/20, case management accounted for 47.8% of the total workplace rehabilitation payments, followed by travel (16.1%), and workplace activities (11.7%).



Other treatment services




In 2019/20, \$6.7 million was paid for other treatment services, accounting for 4% of all treatment service payments. The total payments for other treatment services decreased (5.8%) from 2016/17 to 2019/20.

Other treatment services include the supply of aids and appliances, orthotics, pharmacy, and home help services. Payments for home help serivces had the largest increase in service payments (5.3%) from 2016/17 to 2019/20, whilst pharmacy treatment service payments had the largest decrease in service payments (15.9%) over the same period.

Proportion of other treatment services payment types

In 2019/20, the supply of aids, appliances and orthotics accounted for 63.6% of the total treatment payments for other services, followed by pharmacy (33.2%).

- physiotherapy
- ambulance
- psychology.

Claim payments

Categories are based on WorkCover WA's Guidelines for Completing Form WC 101. Claim payments are in contrast with claim costs as they do not reflect liabilities incurred but not yet paid. Claim payment information is collated based on the financial year during which payment was made, regardless of when the claim was lodged with the insurer. In this report, claim payments are reported both in adjusted and unadjusted formats. In relation to the former, payments are adjusted for inflation to allow for meaningful comparisons over time.

Financial year

Refer to Service year/quarter.

Medical service payments

Payments made under Clause 17(1), (3) and (5) of Schedule 1 of the *Workers' Compensation and Injury Management Act 1981*. These payments are made to Medical/General Practitioners who treat the injured worker. It includes consultation and treatment expenses. It also refers to total payments made to Specialists to whom the Medical/General Practitioner refers the injured worker. It includes consultation and treatment expenses rendered by Specialists.

Non-scheduled items

Procedures which are not included in the schedule of medical items for which WorkCover WA sets prescribed fees.
